





No work shall be approved that causes a drainage problem to any adjacent property. All structures shall have a finished floor elevation of not less than one-foot above the top of curb/center of road. No structure or pavement shall be allowed over any City of Conroe easement without written permission of the Director of Community Development. No certificate of occupancy shall be issued until all compliance requirements are met. This permit shall become null and void after six (6) months from date issued unless extended by the Building Official.</p>
