FIRST AMENDED ORDER

- 1. Came on for consideration Plaintiff's Emergency Motion to Modify Temporary Restraining Order and Motion to Hold Paul Simpson in Civil Contempt, after considering the pleading the affidavits, and arguments of counsel, this Court FINDS that there is evidence that harm imminent to Plaintiff PAUL COSELLI and if the Court does not modify the temporary restraining order. Plaintiff PAUL COSELLI will be irreparable injured.
- 2. This order is necessary because there was not enough time to give notice to all Defendant hearing, and modify the restraining order before the irreparable injury to PAUL COSELLI Specifically, January 8, 2018 is the last day to have PAUL COSELLI'S name placed on the primary ballot for the 281st Judicial District Court in Harris County, Texas and PAUL SIMPS has continued to keep PAUL COSELLI off the March 2018 Harris County Republican Primary ballot.
- 3. This order is necessary because in the event this Court does not modify its previous order dated January 2, 2018 there is evidence that harm is imminent to Plaintiff and he will be irreparate injured because once Harris County Republican Party by and through PAUL SIMPSON provides its final list to STAN STANART on January 8, 2018, it will be too late for Plaintiff to exercise its rights to run for elected office.
- 4. To maintain the status quo, PAUL SIMPSON, his agents, servants, employees, independent contractors, attorneys, representatives, and those persons in active concert or participation with him who receive actual notice of this ORDER are hereby ORDERED to and must reinstate PAUL COSELLI'S name on the March 2018 Republican Primary Ballot.
- 5. To maintain the status quo, STAN STANART, his agents, servants, employees, independent contractors, attorneys, representatives, and those persons in active concert or participation with him who receive actual notice of this ORDER are hereby ORDERED to and must reinstate PAUL COSELLI'S name on the March 2018 Republican Primary Ballot.
- 6. PAUL SIMPSON, his agents, servants, employees, independent contractors, attorneys, representatives, and those persons in active concert or participation with him who receive actual notice of this ORDER are ORDERED and restrained from removing PAUL COSELLI'S name from the March 2018 Republican Primary Ballot and cannot remove it from the ballot unless otherwise directed by this Court.

- 7. STAN STANART, his agents, servants, employees, independent contractors, attorneys, representatives, and those persons in active concert or participation with him who receive a first notice of this ORDER are ORDERED and restrained from removing PAUL COSELLI'S nate from the March 2018 Republican Primary Ballot and cannot remove it from the ballot unless otherwise directed by this Court.
- A violation of this Order shall be punished by contempt of Court, which is punishable by confinement in Jail for up to six (6) months and a fine of up to \$500.00.
- Beginning January 9, 2018, PAUL SIMPSON will incur a daily monetary sanction of

 Republican Primary ballot.
- 10. This Court admonishes Paul Simpson and warns him that he can and may be imprisoned for a paul 6 months in the event he continues to ignore this Court's orders.
- 11. IT IS FURTHER ORDERED that Plaintiff shall execute and file with the clerk of this Course band, or cash deposit of \$20 in lieu of a bond in conformity with Rule 684 of Texas Rules of
- 12. A hearing on a temporary injunction is hereby set on January 16, 2018 at 1:00 P.M.
